Initial Observation Report for Special Voting Day in the 2025 Parliamentary Elections

Introduction:

The parliamentary elections in Iraq represent a pivotal milestone in the trajectory of democratic transformation and the enhancement of political participation. Amid the security, administrative, and technical challenges facing the electoral process, the importance of an independent monitoring role becomes increasingly evident to ensure the integrity and transparency of voting.

In this context, the Alliance of National Networks and Organizations for Election Observation in Iraq conducted an extensive monitoring operation, covering all phases of Election Day across the various governorates, through thousands of professionally trained field observers. 8,347 electronic monitoring forms were collected and analyzed, encompassing organizational, technical, security, and behavioral indicators, thereby enabling the presentation of an accurate and comprehensive picture of the electoral process.

This oversight effort is not limited to documenting violations; it also aims to strengthen accountability, provide practical recommendations to improve institutional performance, ensure the protection of voter rights, and foster a fair and secure electoral environment for all stakeholders.

Executive Summary

Election day in Iraq witnessed a large-scale monitoring operation implemented by the Alliance of National Networks and Organizations, through more than 8,300 monitoring forms distributed across the opening, voting, closing, counting and sorting phases, in addition to recording incidents and general assessment. Data was collected from 18 governorates, which gives the report high representational strength and reflects the diversity of administrative and security contexts in the country.

Sample Strength and Indicator Diversity

- The observation forms included 33 monitoring indicators covering organizational, technical, security, and behavioral aspects.
- A total of 3,273 incidents and violations were recorded, reflecting the magnitude of structural challenges facing the electoral process.
- Variations in performance among governorates and electoral teams enabled comparative analysis that highlights areas of strength and points of weakness.

Implications of Discrepancies

- While some polling stations demonstrated a high level of compliance with procedures, others recorded serious violations, reflecting disparities in training, oversight, and operational readiness.
- These discrepancies highlight the need to standardize procedural criteria and further develop both internal and external monitoring mechanisms.

Scope of Monitoring Coverage by the Alliance of Networks

Observers from the Alliance of Networks participated in comprehensive coverage of election day, collecting a total of 8,347 monitoring forms distributed across the various stages of the electoral process as follows:

These figures reflect the extensive coverage and methodological rigor applied by the Alliance in monitoring the electoral process, thereby enhancing the credibility of the findings and providing the analysis with a high degree of representativeness.

Most Prominent Violation Patterns

1. Organizational and Technical Problems

- Delayed opening at some polling stations
- Malfunctions in some verification and electronic transmission devices
- Absence of electoral team members in Diyala and Najaf

2. Violations Affecting Voting Integrity

- Voting without official identification in Baghdad and Nineveh
- Collective voting and bringing mobile phones into polling stations in Al-Muthanna and Baghdad
- Discrepancies between manual and electronic results in Erbil and Babylon

3. Violations Infringing on Voter Rights

- Prevention of assistance to persons with special needs in Najaf and Al-Muthanna
- Disenfranchisement due to fingerprint and photograph problems in Nineveh and Baghdad

4. Political and Security Interference

- Intervention by security forces in Anbar and Baghdad
- Pressure from party agents in Nineveh and Sulaymaniyah
- Recorded cases of threats and harassment at multiple centers

Analysis of Incidents and Breaches on Election Day

A total of 3,273 incidents and violations of various types were recorded in monitoring forms, distributed across the opening, voting, counting and sorting phases, in addition to security and organizational aspects. These data reflect the magnitude of challenges that confronted the electoral process and provide a basis for identifying reform priorities.

⋄ Recorded Breaches:

- Voting without a second official identification document: 40 cases
- Voting in Group: 92 cases
- Presence of unauthorized persons inside polling stations: 89 cases
- Objections to announced results: 68 cases
- Bringing mobile phones into polling stations and photographing ballot cards

These cases undermine the essence of the democratic process and necessitate a review of verification and authentication mechanisms.

Security and Behavioral Breaches:

- Prevention of political entity agents from being present: 86 cases
- Prevention of observers from being present during opening: 89 cases
- Threats or harassment: 28 cases
- Restriction of observer movement and rights: 89 cases
- Attempts to prevent voters from accessing polling stations: 23 cases

These breaches indicate unjustified interference with freedom of oversight and participation, and call for clear protective measures.

◆ Procedural and Technical Breaches:

- Delayed opening of polling stations: 108 cases
- Failure to implement closing procedures: 61 cases
- Failure to transmit results electronically: 65 cases
- Delay or failure in printing results tape: 115 cases

These indicators reflect weaknesses in technical and administrative readiness and affect the accuracy and speed of results announcement.

The ultimate goal remains building an Iraqi electoral system that is more transparent, more equitable, and more capable of representing the will of the people.
